is a nonprofit organization that was established in 1953 to honor John W. Dargavel, NCPA's Executive Secretary from 1933 to 1961. Its goal is to provide educational and research support to pharmacy faculty, students, and practitioners and to assist future professionals through the provision of scholarships and low-interest educational loans. The Foundation's educational grants contribute to the success of independent community pharmacy through research awards and service projects to improve patient care.

Policies for the Foundation are approved by a seven-member Board of Directors. A 16-member Advisory Council, which is composed of individuals serving in a variety of pharmacy disciplines provides valuable input to the Board. NCPA Past-Executive Vice President Charles West currently serves as president of the Foundation.

### 2001 Annual Report of the President

The NCPA Foundation is pleased to continue to use its resources to provide useful, real world support to independent pharmacists and pharmacy students. As the Foundation nears its 50th anniversary, we are pleased to continue the principles espoused by the Foundation's namesake, John Dargavel. The past year has been an active one for the Foundation. The Foundation continues to lead the way in pharmacy education and in providing useful tools for pharmacy practitioners. In addition to providing scholarships and educational loans, two areas in which the Foundation is well known throughout the pharmacy community, the Foundation is active in a host of other areas.

### Independent Pharmacy Research

This past year, the Foundation provided funding for research to provide guidance on the implementation of dispensing technology in a community pharmacy. Donna West, R.Ph., Ph.D., University of Arkansas, examined three different dispensing technologies and suggested which technologies might be most beneficial to community pharmacies based on varying prescription volumes and patient service expectations.

### Presidential Scholarships

The Foundation, with support from industry, provided 15 \$2,000 scholarships to pharmacy students. The Presidential Scholarships are awarded to pharmacy students with an interest in independent community pharmacy who have demonstrated leadership and high academic achievement. In addition to the \$2,000 scholarships, the Foundation provides travel expenses for these students to attend the NCPA Annual Convention where they are presented with the award during an awards luncheon and ceremony.

### J.C. and Rheba Cobb Memorial Scholarship

In memoriam to former NARD President and longtime Foundation Board Member, J.C. Cobb, the Foundation annually awards the J.C. and Rheba Cobb Scholarship to a student demonstrating outstanding leadership and an interest in community and government affairs. This year's recipient is Jayme Steig of North Dakota State University.

### John W. Dargavel Medal

The Dargavel Medal is awarded for exceptional service to independent community pharmacy. This year, the medal was awarded to Sal D'Angelo of New Orleans. Mr. D'Angelo is a longtime supporter of community pharmacy and an advocate of political awareness in the profession.

### Corporate Recognition Award

The 2001 Corporate Recognition award was presented to Pharmacia Corporation. Pharmacia, in addition to their commitment to the *NCPA-Pharmacia Digest*, has demonstrated their support of community pharmacy in numerous ways including sponsoring educational town hall meetings, graduate leadership programs, and long term care pharmacy initiatives.

### Disaster Relief Fund

The Foundation's Disaster Relief Fund provided financial assistance to pharmacists in Alabama and West Virginia where a pharmacist's residence and pharmacy were affected by fire and flood, respectively. The Foundation provided funds to assist in the restoration of the home and recovery of operations that were impacted.

### NCPA Pharmacy Ownership Workshop

This three-day program covered management topics such as financial management, marketing, human resource management, and legal and ethical considerations in pharmacy ownership. The Foundation also provided sponsorship for NCPA Management Programs at the convention.

### Annual Dean's Luncheon

Each year, NCPA hosts a luncheon for pharmacy school deans and NCPA faculty liaisons during the American Association of Colleges of Pharmacy Annual Meeting. This year's meeting in Toronto, Ontario was attended by nearly 100 deans and liaisons. A brief

presentation was given during the luncheon that highlighted Foundation activities.

### Commitment to Support Pharmacy Students

The Foundation continues to stand out as the largest pharmacy association foundation provider of financial support for the nation's undergraduate pharmacy students. Since its inception, the Foundation has contributed nearly \$5.5 million dollars in scholarships, loans, and grants to further pharmacy education for nearly 10,000 pharmacy students. Since 1990, 162 Presidential Scholarships have been awarded to students from 46 different schools. The Foundation also provides funds to assist NCPA staff to give presentations at pharmacy schools encouraging students to join NCPA and to become active in the profession.

### Dargavel Chapter of the Year

There are currently 45 NCPA Student Chapters in the nation's pharmacy schools. The Foundation recognizes the top three chapters and the most improved chapter by awarding \$2,000, \$1,500, and \$1,000 to the top three chapters in the nation, respectively. The 2000 Chapter of the Year recipient was the University of Kansas School of Pharmacy. The University of Arkansas and Midwestern University-Glendale were awarded first and second runner-up, respectively. Oregon State University was the most improved chapter.

### NCPA Student Advisory Committee

This student committee was selected based on their leadership abilities and interest in independent community pharmacy. The Foundation funded the committee's travel to Washington, D.C. where they participated in the NCPA Steering Committee policy formulation process. Additionally, this committee offered invaluable input and guidance on NCPA student programs.

### NCPA Summer Intern

This year, Stephanie Erwin of the University of Houston was selected as the NCPA summer intern. Ms. Erwin worked on a number of projects including student program planning, medication safety videos, and technology initiatives.

### Effective Pharmacy Management (EPM) Resource Kit

The EPM Resource Kit is a self-contained program of 16 individual modules designed to teach students and others about the many areas involved in developing and owning a community pharmacy practice. The 9th edition of EPM is currently under construction and is scheduled for release on CD-ROM in late spring.

### The New Independent

Three times a year, a newsletter for pharmacy students is distributed. This newsletter highlights activities of NCPA student chapters, student programs at the NCPA Annual Convention, and reports news important to tomorrow's leaders of independent community pharmacy.

### Partners in Pharmacy

The Foundation provides funds to offset the travel expenses of Partners in Pharmacy (formerly WONARD) scholarship recipients.


### William Wickwire Scholarship

### NCPA Foundation Student Loan Program

The NCPA Foundation continues to be a source of educational financial assistance for pharmacy students. During the 2000-01 school year, the Foundation loaned over \$91,500 to pharmacy students. Full-time undergraduate students enrolled in their last two-and-one-half years of school who meet the loan criteria are eligible for these educational loans. Students may request up to \$1,500 each semester for a total maximum of \$7,500 over two-and-one-half years.

Over the past 10 years, each accredited school or college of pharmacy has had at least one student that has received an educational loan from the NCPA Foundation.

Nearly 10,000 loans totaling almost \$5 million have been awarded to pharmacy students to assist them with costs associated with their education.

### 2001 J.C. & Rheba Cobb Memorial Scholarship Recipient



The J.C. and Rheba Cobb Memorial Scholarship is presented to a student who displays an interest in civic and government affairs, exhibits leadership characteristics, and demonstrates high academic achievement. This scholarship was created in 1999 to honor former NARD president, longtime NCPA Foundation Board member, and tireless supporter of independent community pharmacy, J.C. Cobb. Born in Iowa Park, Texas, Mr. Cobb purchased his pharmacy in Tishimingo, Oklahoma in 1940. Among his many accomplishments, he received the Dargavel Medal from the NCPA Foundation in 1968, actively supported both Oklahoma pharmacy schools, and was involved in state and national governmental affairs throughout his career.



Jayme Steig from North Dakota State University is the 2001 recipient of the J.C. and Rheba Cobb Memorial Scholarship. Jayme was one of the founding members and the first president of the recently established NCPA Student Chapter at NDSU. He was named to the NCPA Student Advisory Committee, attended the NCPA Legislative Conference in Washington D.C., and served on the North Dakota Pharmaceutical Association Government Affairs Committee. He has also worked as a pharmacy intern in an independent pharmacy during school. NDSU Dean, Dr. Charles Peterson had this to say about Jayme, "Jayme has the knowledge, attitude, effort, leadership abilities and people skills for what it takes to be successful."

### **NCPA Foundation Research Grant Programs**

The 2000-01 NCPA Foundation Research Grant Program research priorities were identified by the eight NCPA Steering Committees and the National Institute for Pharmacist Care Outcomes Advisory Committee. These recommendations were then approved by the Foundation Board and a request for proposal was sent to pharmacy school deans and faculty liaisons.

An Economic Justification of the Use of Dispensing Technologies in Independent Community Pharmacies

Donna West, R.Ph., Ph.D., University of Arkansas for Medical Sciences

Economically justifying the use of automated dispensing technology (e.g. pill counters, robotics, dispensing computers) was the topic of this year's NCPA Foundation Research Grant study. Donna West, R.Ph., Ph.D., University of Arkansas for Medical Sciences, received funding from the Foundation to support a study that compared some of the available dispensing technologies and evaluated them for their effect on productivity and cost effectiveness.

"We have talked to many pharmacists who are interested in new technology that will help to increase productivity but the addition of these tools often requires a substantial financial investment," according to Dr. West, lead investigator for this project. "The study is designed to compare the selected dispensing technologies to traditional pharmacy practice and determine if there are any significant economic benefits."

The study first developed and validated a simulation model that accurately reflected the workflow of an independent community pharmacy and then used computer simulation to determine the differences in efficiencies among robotics, dispensing computers, and pill counters.

### NCPA Foundation Supports NCPA Student Advisory Committee

### 2001 Outstanding NCPA Faculty Liaison

The Foundation began recognizing the Outstanding NCPA Faculty Liaison in 2001. This award goes to a faculty member who has helped to catalyze NCPA Student Chapter involvement by providing guidance and advice to students to assist them in developing skills and attitudes that help to shape them as community pharmacists. This year's award went to Gene Hotchkiss of the University of Kansas.

Gene Hotchkiss is a lifetime Kansan. He is a native of Burlingame, Kansas where he graduated from high school. He attended Washburn University in Topeka, before coming to the University of Kansas to finish his pre-pharmacy and pharmacy coursework. In 1969 he graduated from the KU School of Pharmacy. Following graduation, he worked as a pharmacist in an independent pharmacy in Topeka and then with the Kansas Department of Social and Rehabilitative Services (Medicaid). In 1986 he took a new position as assistant to the dean at KU. In 1998, he was named the Chapter's NCPA Faculty Liaison. During the past three years, the chapter has been named "Most Improved," and has earned the top award as "Dargavel Chapter of the Year" the past two years. Mr. Hotchkiss has been instrumental in facilitating the chapter's involvement in health fairs consisting of glucose and cholesterol measurements, bone density screenings, and blood pressure testings. He also helped the chapter arrange a diabetic foot screening program.

Another innovative program that Mr. Hotchkiss has coordinated is the field trip visitation program to independent pharmacies. KU pharmacy students spend a day with Kansas pharmacists learning firsthand about pharmacy ownership. Mr. Hotchkiss is also a key figure in the KU Summer Camp for Kansas high school students, a week long camp that encourages students to choose pharmacy as a career. Mr. Hotchkiss has utilized the NCPA Student Chapter at



KU to assist pharmacy students in taking their classroom skills and applying them in a real world setting providing experiences that students can draw on throughout their career.

### John W. Dargavel Medal

The Foundation presented the John W. Dargavel Medal to **Sal D'Angelo**, **P.D.** The Dargavel Medal is awarded to a pharmacist for outstanding service to community pharmacy. A graduate of the University of Houston, Mr. D'Angelo has been a member of NARD/NCPA since 1955 and served as president of NARD in 1976-77. He is currently the chairman of the NCPA-PAC.

He is a longtime member of the Louisiana Board of Pharmacy, serving on the board from 1965 through the expiration of his term in 2004—the longest uninterrupted term in Board history. Mr. D'Angelo has the unique distinction of being named Louisiana Pharmacist of the Year four times, in 1960, 1965, 1974, and 1983--the only person to receive the award more than once. He has been a member of the Louisiana Pharmacists Association since 1955 and was elected president in 1962-1963. Mr. D'Angelo is also very active in

fundraising for the New Orleans Pharmacy Museum—the site of the first licensed pharmacy in the United States.

His awards and honors are too numerous to mention in their entirety. In 1996, Mr. D'Angelo was a recipient of the Charles M.West, Distinguished American Award and in 1967 received the Bowl of Hygeia award. He has served on the advisory board of numerous organizations throughout his career including SKF Laboratories, Northeast Louisiana University, and the Louisiana Department of Health and Human Services. As NARD Past President, Lou Mitchell wrote in recommending Mr. D'Angelo, "His activity on behalf of the profession is well known and transcends all phases of pharmacy." Mr. D'Angelo and his wife Charlotte, also a licensed pharmacist, have four children.





### Trusts Provide a 'Win-Win'

Charitable remainder trusts (CRT) are growing in popularity and provide a vehicle to reduce estate taxes, eliminate capital gains, claim an income tax deduction, and benefit foundations and charities.

Charitable remainder trusts are irrevocable trusts that allow you (and your spouse) to receive a set percentage of income for your lifetime from the trust. A second set of beneficiaries are the foundations or charities that you name. They receive the principal of the trust after the income beneficiaries pass away.

The amount of income to come out of the CRT depends on the payout percentage that you choose. One of the major advantages to a Charitable Remainder Trust is that they do not pay any capital gains taxes. CRT's are ideal for assets like stocks or property with a low cost basis but high appreciated value.

CRT's also can benefit those still in their peak earning years. Contributions can be made to the CRT in the form of zero coupon bonds, non-dividend paying growth stocks, or professionally managed variable annuities. Upon retirement, the CRT can begin making payouts after retirement. Unlike IRAs or a 401(k) there are no limits on how much may be contributed. A CRT is considered "outside of your estate" by the IRS. Because of this, you may end up saving as much as 55 cents of every dollar you move to the CRT. CRT's also qualify for an income tax deduction.

Trusts can serve a variety of purposes in estate planning, including to:

- Conserve property for your beneficiaries
- Help manage your investments
- Avoid guardianship requirements applicable to property transfers to minors and other legally incapacitated persons
- Minimize probate costs by transferring property before death
- Reduce or eliminate estate taxes for beneficiaries of your estate
- Keep arrangements private by avoiding the public probate process

Trusts are not for everyone. Please consult with your financial advisor and an experienced estate planning attorney to discuss if a trust would be beneficial for your particular situation.
